CHAIR'S REPORT

As we enter our 26th year at the Water Directorate, our role and strategic focus have never been more important. Once again, our regional communities have experienced new extremes in climate that has tested the resilience of water and sewerage services. It is often forgotten that the water and sewerage functions in a Local Water Utility are 24-hour, 365-days per year operations within all the numerous functions of local government. I want to thank all the operators, technicians, engineers and scientists that maintain essential water and sewerage services for two million people living and working across regional NSW.

Water Directorate Strategy 2030

Last December, we launched the Water Directorate's most expansive and ambitious strategy yet, Strategy 2030. We took the time to listen to all the feedback from the water managers in our member local water utilities and re-confirmed our mission, vision and strategic direction.

Our four key Strategy Focus Areas were confirmed as:

1. Address regulatory challenges and promote innovation
2. Knowledge sharing and knowledge management
3. Local water utility risk and resilience
4. Workforce development – skills, knowledge and training

Our third Water Directorate Annual Forum – Bridging the Skills Gap in our Water Workforce

In September 2024 we hosted the third Water Directorate Annual Forum, bringing together regional and remote water professionals from across NSW to meet with regulators, industry and partner water organisations.

Addressing skills shortages in water utilities in regional NSW is one of our highest priorities. We can't provide our essential services without well trained operators, engineers and scientists. Our keynote speaker Sophie Renton reminded us of the needs of different generations that will participate in our sector now and into the future. Water Research Australia shared leading research with the aim of developing a more consistent approach to water operator training. The newly formed BuildSkills Australia presented on national water sector development.

Thanks to Executive Officer Brendan Guiney, and his team Jessica Gralton, Sarah Eastman and Juliet Cobb for their work in putting the Forum together and for all their hard work over the past year. It's timely that the latest addition

to the team, Fiona Setu, is taking on the role of Manager of Regional Partnerships and Capability Development.

Collaboration and advocacy

My thanks go out once again for the continued support of the Australian Water Association. In April, the AWA in partnership with the University of Sydney hosted a roundtable with the Minister for Water, Rose Jackson MLC, and we were pleased that our Minister focussed on challenges facing Local Water Utilities regional NSW. Budgets are limited. There are no easy answers. We were grateful to be involved in a discussion that involved incentivising regional collaboration between local water utilities and developing a roadmap for digital transformation for local water utilities.

Thanks to our Executive Committee

My thanks as always for the volunteer input from our current 18 Executive Committee members, as well as Councillor Dominic King, and Shaun McBride and Anthony Luu of Local Government NSW for continuing our ongoing, close working relationship on policy and advocacy in regional water.

In March 2025 we had our regular changing of the guard through our two-yearly elections. Sincere thanks to outgoing committee members Russell Deans of Bathurst Regional Council, Derek Finnigan of Muswellbrook Shire Council, Trevor Sultana of Goulburn Mulwaree Council, Chris Witney of Snowy Monaro Regional Council and Marnie Coates of MidCoast Council. Welcome to Steve Marshall at Bega Valley Shire Council, Graham Attenborough at Eurobodalla Shire Council, Danielle Hargreaves at Central Coast Council, Michael McKenzie at Rous County Council and Katie Hardy at Singleton Shire Council. We have some work to do!

It has been a privilege to continue as Chair the Water Directorate again this year and I thank all our government and non-government collaborators along with our own local water utilities that have pulled together in the common cause of safe, secure and affordable water and sewerage services to all in New South Wales.

EXECUTIVE OFFICER'S REPORT

It's a privilege to serve as your Executive Officer at the Water Directorate, providing technical advice and advocating for our 90 Local Water Utility (LWU) members across regional NSW and collaborating with government and non-government bodies to ensure the delivery of safe, secure and affordable water and sewerage services for all regional NSW communities.

Town Water Risk Reduction Program

Phase 2 of Department of Climate Change, Energy, Environment (DCCEE) and Water's Town Water Risk Reduction Program (TWRRP) concluded in June 2025 with support programs such as the Regional Leakage management program, Advanced Operational Support program, Skills and Training action plan, as well as the WHS uplift program providing excellent results. Water Directorate has held an influential role in the delivery of these programs, and the assistance provided has been very well received by participating LWUs.

We were pleased to hear the Minister announce that TWRRP will enter a third phase with a further \$15 million assigned to the program over the next three years 2025-2028. This is very welcome news and critically important to continue LWU performance uplift and reduce risk.

Contaminants of Concern

Unfortunately the impact of contaminants of concern on the water sector is increasing as we find more of these persistent chemicals, especially PFAS, in the water cycle with broader testing. We submitted to the NSW Parliamentary Inquiry into PFAS Contamination in Waterways and Drinking Water Supplies that source control of PFAS is the most effective approach to mitigating PFAS risk in water supplies. Regrettably, sampling in 2024 showed a number of local water utility source water sites affected by PFAS which not only threatens drinking water quality, but also water security as these compromised water sources cannot be used as planned. These concerns also extend to our wastewater systems including effluent return flows, biosolids management and water recycling. We will continue to advocate for LWUs, who did not cause this contamination. Costs must be managed under the 'polluter pays' principle. We need practical, affordable regulation of biosolids to allow LWUs to use biosolids as a resource rather than a waste product as part of the circular economy.

Thanks to Local Government NSW

At the 2024 Local Government NSW Water Management Conference in Goulburn we co-presented on Strategic Planning for Local Water Utilities, with thanks to Central NSW Joint Organisation and Port Macquarie Hastings

Council. We continue to advocate for recognition that LWU strategic planning is practical and achievable using the NSW Local Government Integrated Planning and Reporting framework. LWUs confirm that for them, strategic planning continues to be onerous and expensive and presents unnecessary burdens.

New online learning products launched

I want to thank DCCEE for their spirit of partnership through the Skills and Training Action Plan and also the Advanced Operational Support (AOS) program. Thanks to DCCEE, at the end of our reporting year we were able to host some new learning resources including:

- Water Operator Safety Card
- Work Health and Safety Awareness Module for Leaders

We will continue to promote our existing very successful AquaCard and BrownCard to ensure all workers are risk aware. We are very grateful for the support and partnership of Qldwater in their production. They are leaders in this space. There are many more learning resources now available, please jump on to our website to learn more.

The DCCEE AOS program also assisted us with building a Standard Operating Procedures library with the aim of reducing operating risk at our treatment plants, minimising errors and to serve as a resource for training new employees and retaining water utility knowledge.

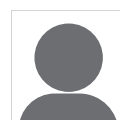

YEAR IN REVIEW

The Water Directorate stepped up its representation and advocacy on behalf of 90 local water utility members during 2024-25 and continued its ongoing dialogue with industry partners and regulators. Some of the highlights during the year were:

Annual Forum 2024 Skills Development



Just under 100 members, sponsors, regulators and stakeholders attended the 2024 Annual Forum.

The theme Dive into Opportunity: Bridging the Skills Gap in our Water Workforce was chosen to recognise the critical skills shortages in the water industry in NSW – with topics such as state and national activities in workforce development, workforce diversity and LWU case studies.



Town Water Risk Reduction Program phase 2 - Extension

The Water Directorate has been closely involved with TWRRP working groups and welcomes the additional \$15 million and extension until 2028. Key elements are:

- Improve access to skills and training
- Advanced Operational Support Program
- Emergency and incident response and WHS
- WaterNSW support for Dam Safety and water data sharing
- Respond to the PEC Review recommendations about funding arrangements for LWUs

The Water Directorate offers free online training for Members and Associate Members, via Aqua, Brown, Green and White (safety) cards. Book via the water [training website](#).

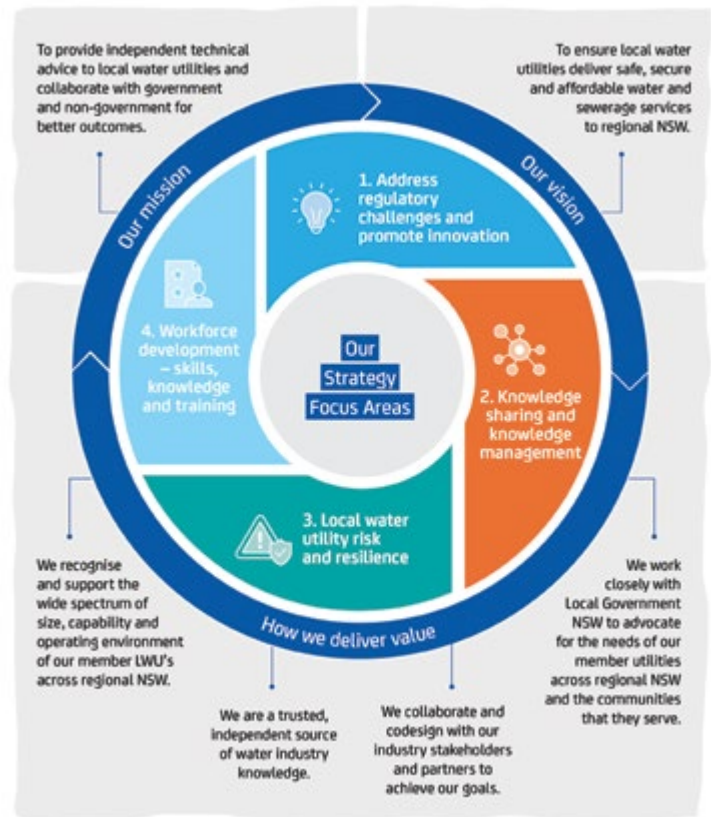


THE PATH AHEAD

Strategy 2030

Strategy 2030 is a roadmap for the Water Directorate, highlighting the key strategic focus areas that will help the organisation deliver on its mission over the coming five years, and demonstrate its commitment to delivering value to members. During the year progress in the focus areas was:

1. *Address regulatory challenges and promote innovation* – contribute to DCCEEW’s Regulatory and Assurance Framework review; work with DCCEEW on their response to PEC report; collaborate with Central JO on a Practitioners Toolkit; survey members on using the IP&R framework for strategic planning; submission to NSW Parliament’s PFAS Inquiry
2. *Knowledge sharing and knowledge management* – start work on a digital utilities strategy for LWUs; contribute to DCCEEW’s WHS awareness materials; 190 SOPs and four online training cards available via Water Directorate website; start on a Knowledge Management Framework for the LWU sector
3. *Water utility risk and resilience* – respond to Productivity and Equality Commission’s report on funding LWUs; advocate on behalf of LWU’s concerning financial risk and affordability issues; engage with DCCEEW on recycled water roadmap; promote minimum standards for operator training.
4. *Workforce development* – skills & knowledge training – support DCCEEW on workforce development plan for regional NSW; raise awareness and opportunities for Aboriginal people to work in the water industry.
