### Chair's report



We have had a strong focus on implementing the Water Directorate Strategic Plan 2019-2024 during the year, responding to the member survey we conducted in 2018. We continue to respond to the top issues members identified in the survey: a shortage of skilled technical staff, ageing infrastructure, cost of maintenance and cost of compliance with new proposed health-based targets.

By the end of the reporting year we had started discussions with partner associations in water and infrastructure to better meet the needs of our member water utilities. This work will continue into the next 6 to 12 month period. Our relationships with our fellow associations will continue to grow into the future as we rise to meet the different challenges the water industry is facing in NSW. Local Government NSW, IPWEA, AWA, WSAA and WIOA and our own organisation will collaborate on skills development and asset management, as well as changes in water industry regulation.

I want to acknowledge our hardworking Executive Committee, who contribute hours in-kind to solve our regional water utility issues. I particularly thank departing representatives Matt Fanning of Bellingen Shire Council who played a key part in the development of our Strategy, Andre Kompler of Tenterfield Shire Council, Rolly Lawford of Warren Shire Council, Terence Seymour of Uralla Shire Council and Michael Herraman of Wingecarribee Shire Council. Welcome to Gnai Ahamat of Snowy Monaro Regional Council, Derek Finnigan of Muswellbrook Shire Council, Doug Moorby of Narromine Shire Council and Greg Whorlow of Albury City Council. The Water Directorate thrives due to the in-kind hours of voluntary work put in by the 18 members of our Executive Committee.

A special thanks to Gary Mitchell for his 20 years of service on behalf of the Water Directorate and the NSW water industry. Gary was present at the embryonic stages of the Water Directorate in 1998. He oversaw the formalisation of the Water Directorate as an incorporated association in 2001. He worked with 11 successive Executive Committees over his two decades to develop more than 80 publications. He facilitated the Water Directorate forum at 16 successive LGNSW Water Management Conferences, that were held in every different region in NSW to listen to our members concerns and shared common issues in water management in regional NSW. The project I know Gary took the most pride in over his time here was his participation in the Water Loss Management Program, a 5-year program operated in partnership with LGNSW and funded by the Commonwealth Government between 2006 and 2011. The Program engaged with 75 local water utilities across NSW and achieved ongoing savings 5.5 billion litres of water per annum. The project was a fantastic example of what the Water Directorate can achieve: large water and energy savings, capacity building of local water utilities and sustainable infrastructure management being the most notable benefits.

The Executive Committee welcomes Brendan Guiney, previously Director of Water Services at MidCoast Council as the new Executive Officer of the Water Directorate. Brendan commenced work with the Water Directorate in April 2019. Brendan's enthusiasm in the role along with his knowledge of the water and sewer industry across regional NSW, makes him an extremely valuable appointment to the Water Directorate going forward.

It is as important as ever for NSW local water utilities to be members of the Water Directorate. Almost all our member water utilities have suffered through drought now for a number of years. We can't rest and will need to adapt, using more diverse water solutions and rigorous asset management, so that our local water utilities can continue to provide sustainable water services into the future.

We will continue to advocate on behalf of the regional water sector in partnership with Local Government NSW, harnessing our unique relationship with rural and regional councils. We will continue to provide the technical support for your operations as the peak body for NSW local water utilities.

### Executive Officer's report

2018/19 was a very significant year in the Water Directorate's relatively brief history as we achieved 100 per cent membership of all 89 local water utilities for the first time, during the organisation's 20th year. We welcomed incoming Executive Officer Brendan Guiney as I retired after twenty years in the job. Brendan and I have worked together during our handover to jointly bring you this report.

The major piece of work for the year was our new Strategic Business Plan 2019 - 2024 developed by Professor Roberta Ryan of Public Policy and Governance Institute in the Centre for Local Government, University of Technology Sydney. The project involved a detailed review of the Water Directorate's work and an online survey of NSW LWUs. The key issues members raised are ageing infrastructure followed very closely by a shortage of skilled technical staff and also by the cost of compliance with HBTs. The results of the survey and review were workshopped at a Water Forum at the LGNSW Water Management Conference, leading to a very thorough understanding of the landscape in which the Water Directorate and our members are operating.

We hope the resulting Strategic Plan will help the Water Directorate to meet the needs of members in the coming years. Full details of our other publications, events and awards may be found on page 10.

Brendan Guiney took over as Executive Officer in April 2019, the second person to hold that role since the Water Directorate was formed in 1998. Brendan was previously the Director Water Services at MidCoast Council and had served as a valuable member of the Executive Committee from 2013. Brendan's appointment gives me great confidence that the Water Directorate is in good hands for the future. In retirement I look back at the growth of the Water Directorate and the liaison with hundreds of dedicated water professionals with fond memories.

The realisation that the current drought has been reported as the worst in 120 years in most of NSW is particularly concerning. Local water utilities should be congratulated for working closely with their local communities to save water and discuss water security solutions. The development of measures such as new water storages and supplementary water sources such as stormwater harvesting, groundwater and recycled water is critical to increasing our resilience in the face of such drastic circumstances. The Water Directorate is available to provide support as these solutions are developed.



## In December 2018 we celebrated **20 years** of providing technical advice to NSW Local Water Utilities.

Over the past 20 years we have convened **124** Executive Committee meetings, facilitated 16 water management forums at LGSA/ LGNSW Water conferences, facilitated **18** water management streams and forums at IPWEA conferences, distributed **234** monthly newsletters, presented **19** excellence awards at IPWEA conferences, presented **15** Ozwater conference attendance awards to young water professionals, presented **6** LGNSW Excellence in the Environment awards, presented **12** Operator of the Year awards at WIOA conferences, published over **80** technical guidelines and manuals on a broad range of water issues as well as input into government publications.

### **Key roles**


